

JEFFERSON COUNTY CONSTABLES

The Code of Alabama defines Constables as elected or appointed conservator of the peace within his/her county, and according to the Alabama Constable Association, they are one of the only two remaining elected peace officers in the world. The common definition of a Constable is an 'elected law enforcement officer'. Under Alabama State Law, Constables have jurisdiction throughout their assigned County and State.

Qualifications to become a Constable are, 'you must be morally and ethically sound, be a citizen of the county and live within the precinct you are running in, with no warrants, having no criminal record, and be 21 years of age so as to carry a firearm.

Constables run in districts identified within their respective county. There are over 17 counties in Alabama where Constables are recognized and where they run for the office of Constable.

The Circuit Clerk receives legal paperwork (Complaints, Summons, Subpoenas, Unlawful Detainers, etc.) and assigns the legal papers to Constables based on their assigned district. Constables serve the legal papers on the individuals or businesses listed in the legal document. Once service has been completed (executed), the paperwork is returned to the Circuit Clerk's office to be filed along with the court documents.
